Important Reminders for the MAIPF Website

07/01/18 Rate Revision



Effective 07/01/18, MAIPF has implemented a Private Passenger base rate revision with an overall impact of +5.7%. Also effective 07/01/18, a revision to the per-vehicle amounts for additional charges to PIP for Private Passenger and Commercial vehicles has been implemented. For Private Passenger vehicles (6 month policy) the MCCA per-vehicle charge increases to \$107. For Commercial vehicles (annual policy) the MCCA per-vehicle charge increases to \$214.

Important Reminders for the MAIPF Website

On June 11th, the new and improved MAIPF website was launched! Below are some important reminders for the new website.



Reminder #1 – Rating Tools

The rating tools (EASi, CARS and MARS) are only accessible under **Producer credentials**. If you log in with the Agency System ID or Agency email address, you will not be given the Rating Tools section under Producer Tools.

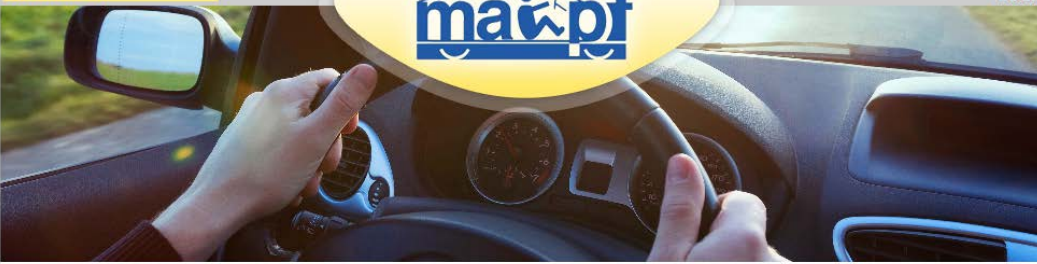
Reminder #2 – Email Address Required for Each File (Producer/Agency)

Each producer in the agency will need their own log in credentials. The email address for each log in will need to be personalized. Duplicate emails between the agency and the producers are not eligible. The email address is used under the “Forgot Password” function and if the same email is listed for duplicate files, the password could be reset for the wrong credentials.

Reminder #3 – Accessing the Producer Tools Page

To access the Producer Tools page, you will need to log in and click on the “Producers” tab at the top of the Home page. A drop down will become available with a “Producer Tools” option.
