### Frequently Asked Question

**Q** – Where can I find the rating symbols to complete a quote for a full coverage vehicle using your private passenger Quick Quote rating system?

**A** – The button at the top of the Quick Quote page “Symbol Look-Up – (AIPSO Login)” will send you out to the AIPSO website where you can query the VIN and locate the comp and collision symbols. It's important to note that you will be prompted for your AIPSO user name and password so it's important to have an AIPSO account set up first. An alternative to the Quick Quote is our EARS product which will give you a complete rate and includes VIN validation and locates the symbols for you.
